Dear Parents/Guardians:

It's time for pre-registration for the 2019-20 school year! This spring, we are using an online registration program "Registar". If you do not have access to a computer or internet, please call the office and we can schedule a time to assist you. Pre-registration will close June 21st. This process will save you time at the final fall registration.

To start the login process we have provided your Parent Internet Viewer (PIV) code on attached label. You must use this number to register your student. Any registrations completed without a PIV code will be deleted. Once logged in on Registar with your new user account, you should see your student's name listed at the bottom of the first screen. If you do not see their name please contact the office at 503-897-2311. Do not "add new student" as you have a returning student. Please note that the Free/Reduced Lunch Program, Student Handbook, and District Handbook are not available to fill out or turn in until August. You will still need to come in to school to finalize registration, pay fees (if applicable), get a locker assignment, and meet with Mrs. Jensen regarding schedule. Below is our registration schedule:

- Monday, August 12th 8am-11:30am and 1pm to 4pm (closed for lunch 11:30am-1pm)
- Tuesday, August 13th- 8am-11:30am and 1pm to 4pm (closed for lunch 11:30am-1pm)
- Wednesday, August 14th- (Evening Session) 11:30am-5:00pm and 6:30pm-9pm (Closed for dinner break 5-6:30pm)
- Thursday, August 15th-(Evening Session) 11:30am-5:00pm and 6:30pm-9pm (Closed for dinner break 5-6:30pm)

All students must register this spring. Again, it can be done independently online or by contacting the office at 503-897-2311.
